Mr. Trey Sanders with Hannis T. Bourgeois, LLP advised the final March Financial Report was complete and submitted to the Board Secretary then reviewed the April 2024 Financial Report along with the Board Members. The Financial Report includes Balance Sheet for assets as well as liabilities and fund balance, Statement of Income, Budget to Actual, and General Fixed Assets.

Mr. Jay LeBlanc with Quality Engineering & Surveying, LLC advised there have been several communications with LPFPD4's attorney regarding the MSAs. Chief Wascom advised that he would schedule a meeting with LPFPD4's attorney and Quality Engineering & Surveying to answer the remaining questions about the MSA. The Board held a discussion regarding the department's current renovation and repair needs.

Chief Wascom advised of an important matter with LPFPD4's generators that needs attention.

Chief Wascom advised the last couple of storms several generators did not operate correctly causing delayed response to emergencies when firefighters can't access garage doors for the apparatus. Omni Metrix Global Monitoring and Controls systems can notify our Chief of Maintenance on a weekly basis if test runs are properly functioning as well as operating properly during a power outage. For thirteen generators, the first year set up fee and equipment is a total of \$17,459.00. The annual monitoring fee after the initial year is \$369.00 per generator for a total of \$4,797.00 per year.

Mr. Falks made the motion, seconded by Mr. Blanchard, to authorize Chief Wascom to approve the contract with Omni Metrix for monitoring LPFPD4 generators.

    engines.
